ORDINANCE NO. SP-21, S-99

AN ORDINANCE AUTHORIZING BARANGAY SACRED HEART TO REGULATE THE USE OF CITY STREETS PARTICULARLY SCOUT FUENTEBELLA EXTENSION, 11TH JAMBOREE STREET AND SCOUT RALLOS EXTENSION, ALL IN QUEZON CITY.

Introduced by Councilors NANETTE CASTELO DAZA and BAYANI V. HIPOL.

WHEREAS, Section 16 of the 1991 Local Government Code provides that every local government unit shall exercise the powers that are necessary, appropriate, or incidental for its efficient and effective governance, and those essential to the promotion of the general welfare and the preservation of the comfort and convenience of its inhabitants;

WHEREAS, the areas surrounding and within the streets sought to be regulated are thickly populated and the sudden increase of public utility plying the said route not authorized under its franchise continues to use the same as alternative routes, to the detriment and prejudice of the residents and passersby;

WHEREAS, there is a need to regulate the use of these city streets to avoid the danger of loss of life, limbs and property and its regulations can be effectively implemented if the Sangguniang Barangay of Barangay Sacred Heart or the barangay officials thereof be given and granted authority or authorized to regulate the use thereof;

WHEREAS, city streets and roads can only be regulated by the city as provided in Section 21, paragraph (d) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Sangguniang Barangay of Barangay Sacred Heart through a resolution had requested authority from the City Council to regulate these city streets on the ground of general welfare and public security, thus, there is no reason why it cannot be granted considering the propriety and wisdom of its request.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Barangay Sacred Heart, District IV, Quezon City, is hereby authorized to regulate the use of city streets, particularly Scout Fuentebella Extension, 11th Jamboree Street, and Scout Rallos Extension, all in Quezon City.


SECTION 2. This Ordinance shall take effect immediately upon its approval.
