AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF CENTENNIAL SUBDIVISION (P.D. 957) WITH 315 LOTS, CONTAINING AN AREA OF THIRTY THREE THOUSAND FOUR HUNDRED THIRTY-SIX (33,436) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NOS. N-145191, N-145192 AND N-145186 OF THE REGISTRY OF DEEDS OF QUEZON CITY AND LOCATED AT LOT 63-A-7, LOT 63-A-8- AND LOT 63-A-9-B (LRC) PSD-290059, BARANGAY PAYATAS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY JCR HOLDINGS CORP., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1.
