AN ORDINANCE GRANTING THE PAYMENT OF A CASH GIFT NOT EXCEEDING THREE THOUSAND PESOS (P3,000.00) EACH TO OUR CONTRACTUAL PERSONNEL AS PART OF THE MAYOR'S PAMASKONG HANDOG PROJECT HOLIDAY SEASON.

WHEREAS, under Sec. 458 (a)(1) (viii) the City Council is authorized to determine and/or grant the payment of salaries, wages allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

WHEREAS, in order to extend Christmas cheer to our contractual personnel, the Honorable City Mayor has certified as urgent a proposed ordinance that would authorize the payment of cash gifts to said personnel as part of the Pamaskong Handog Project under the Office of the City Mayor.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. Contractual personnel who have rendered continuous service for one (1) year as of 31 December 1998 and are still in the service shall be granted a cash gift not exceeding Three Thousand Pesos (P3,000.00) each as part of the Pamaskong Handog Project under the Office of the Mayor.

SECTION 2. The amount necessary for the payment of such cash gift may be taken from savings of any item of expenditures provided in the Annual City Budget for CY 1999.


SECTION 3. The cash gift herein granted to the contractual personnel shall be subject to the guidelines prescribed by the Honorable City Mayor.
