ORDINANCE NO. SP- 864 , S-2000

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE BARANGAY CHAIRMAN ARTEMIO P. FERRERAS OF BARANGAY WEST KAMIAS, WHO DIED ON FEBRUARY 13, 2000.

WHEREAS, a stalwart in barangay service in Quezon City, a faithful and dutiful father to his constituents whom he served for more than twenty-five (25) years with love and dedication as Kagawad and as Barangay Chairman, had passed away, succumbing to a heart ailment in the line of duty, in the thick of a fiesta celebration on February 13, 2000;

WHEREAS, in deference and recognition of his dedicated services, it is but proper that the City government extend to his family a financial assistance as a traditional expression of sympathy and in order to lessen, in some way, the blow of the tragedy to his loved ones;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The amount of Thirty Thousand Pesos (P30,000.00) is hereby allocated from any available fund in the City Treasury as financial assistance to the family of the late Barangay Chairman Artemio P. Ferreras who died due to heart ailment on February 13, 2000.
