ORDINANCE NO. SP- 879 \_ , S-2000

AN ORDINANCE AMENDING ORDINANCE NO. SP-582, S-97, IN ORDER TO CORRECT THE NUMBER OF SALEABLE LOTS OF THE RESIDENTIAL SUBDIVISION PLAN (CMP) APPROVED THEREIN.

Introduced by Councilors WINSTON "Winnie" T. CASTELO, ENRICO S. SERRANO, ERIC Z. MEDINA and ALMARIO E. FRANCISCO.

WHEREAS, under Ordinance No. SP-582, S-97, the Quezon City Council approved the Subdivision Plan (CMP) of Lot 105-B-1, Psd-33274, containing an area of Six Thousand (6,000) square meters, covered under Transfer Certificate of Title Numbered RT-84300 (25542) of the Registry of Deeds of Quezon City, registered in the name of Manuel S. Soriano, Jr., (Vendor), located at Purok 2, Barangay Bagong Silangan, Quezon City, Metro Manila, as applied for by Tagumpay ng mga Magkakapitbahay Homeowners Association, Inc., (Vendee);

WHEREAS, there is a need to amend the said Ordinance in order to correct the number of saleable lots approved therein from One Hundred Twenty-Six (126) lots to One Hundred Twenty-Five (125) lots;

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED,

SECTION 1. Section 1 of Ordinance No. SP-582, S-97, with respect to the item indicating the number of saleable lots is hereby amended, as follows:

"No. of Saleable Lots : One Hundred Twenty-Five (125) lots"
