ORDINANCE NO. SP- 8 80 S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF AN NHA-ZIP LIBIS-MURPHY HOUSING PROJECT (BP BLG. 220) WITH ONE HUNDRED FIFTY-NINE (159) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TEN THOUSAND EIGHT HUNDRED SIXTY-NINE (10,869) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-97513 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF NATIONAL HOUSING AUTHORITY (NHA), AND LOCATED AT LOT NO. 49-C-2-A-10, PSD-3243, E. RODRIGUEZ JR. AVENUE, BRGY. LIBIS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY NHA, REPRESENTED BY MS. GERONIMA B. ANGELES, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP 56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of an NHA-ZIP Libis-Murphy Housing Project (BP Blg. 220) with One Hundred Fifty-Nine (159) lots, Community Mortgage Program, containing an area of Ten Thousand Eight Hundred Sixty-Nine (10,869) square meters, covered by Transfer Certificate of Title No. RT-97513 of the Registry of Deeds of Quezon City, registered in the name of National Housing Authority (NHA), and located at Lot No. 49-C-2-A-10, Psd-3243, E. Rodriguez Jr. Avenue, Brgy. Libis, Quezon City, Metro Manila, as applied for by NHA, represented by Ms. Geronima B. Angeles, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220.


