ORDINANCE NO. SP- 881 S-2000

APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH FOUR (4) LOTS, CONTAINING AN AREA OF TWO HUNDRED FORTY (240) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-57965 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF ROSA B. CARINGAL, AND LOCATED AT LOT 19, BLOCK 40, PSD-14959, IRIGA STREET, BARANGAY SAN ISIDRO LABRADOR, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG.220.




