ORDINANCE NO. SP- 892 - : S-2000

AN ORDINANCE CREATING ONE PLANTILLA POSITION OF REPRODUCTION MACHINE OPERATOR III (SALARY GRADE 7) UNDER THE COMMUNITY RELATIONS OFFICE, OFFICE OF THE CITY MAYOR, AND APPROPRIATING THE AMOUNT OF ONE HUNDRED TWENTY-TWO THOUSAND SEVEN HUNDRED FIFTY-SEVEN PESOS AND NINETY-TWO CENTAVOS (P122,757.92) FOR THE PURPOSE.

WHEREAS, the present economic situation requires the full utilization of manpower and equipment which will in the long run contribute to the efficient and economical management in the pursuit of every office functions;

WHEREAS, the Community Relations Office has reproduction equipment necessary in the implementation of their office's programs and projects and has the personnel who has the knowledge and skill to handle, operate, and maintain these equipment;

WHEREAS, in order to officially designate a permanent operator of these equipment, the said office requested the City Council to create one (1) position of Reproduction Machine Operator III with Salary Grade 7 so that a sole operator will officially handle and maintain said equipment;

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby created one (1) plantilla position of Reproduction Machine Operator III (Salary Grade 7) under the Community Relations Office, Office of the City Mayor.

SECTION 2. The amount of One Hundred Twenty-Two Thousand Seven Hundred Fifty-Seven Pesos and Ninety-Two Centavos (P122,757.92) is hereby appropriated from any available funds in the City Treasury to cover the salaries, insurances and other benefits for the position created in Section 1 hereof.
