ORDINANCE NO. SP- 898 S-2000

AN ORDINANCE CHANGING THE PRESENT POSITION TITLE OF CITY GOVERNMENT OFFICE HEAD III TO CITY GOVERNMENT OFFICE HEAD WITHOUT CHANGE IN SALARY GRADE TO CONFORM WITH THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) NEW INDEX OF OCCUPATIONAL SERVICE (IOS) AND THE REVISED QUALIFICATION STANDARDS (QS) MANUAL OF THE CIVIL SERVICE COMMISSION.

WHEREAS, the office head position under the Quezon City government were classified from their working titles as CITY GOVERNMENT OFFICE HEAD III at Salary Grade 26 upon the implementation of R.A. 6758, otherwise known as the Salary Standardization Law of 1989;

WHEREAS, in the new Index of Occupational Service (IOS) of the Department of Budget and Management and in the Revised Qualification Standards (QS) Manual of the Civil Service Commission (CSC), the benchmark III has been deleted;

WHEREAS, it is necessary that the position title of City Government Office Head III at SG 26 be changed to City Government Office Head with the same salary grade to conform with the DBM-IOS and the CSC Revised QS Manual;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:



The present position title of City Government Office Head III is hereby changed to City Government Office Head without change in salary grade to conform with the DBM new Index of Occupational Service (IOS) and the Revised Qualification Standards (QS) Manual of the Civil Service Commission.


SECTION 2. This Ordinance shall take effect upon its approval.
