AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF CHATEAU EMERIE; A 2-STOREY SINGLE-DETACHED RESIDENTIAL HOUSING PROJECT WITH NINE (9) UNITS, CONTAINING AN AREA OF ONE THOUSAND EIGHT HUNDRED NINETY-FIVE SQUARE METERS AND TWENTY THREE SQUARE DECIMETERS (1,895.23 SQ. M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-160324 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF FELISA S. KEH AND MAXIMO C. CHAN, JR., AND LOCATED AT LOT 1-K, PSD-00-41019; NO. 16 8TH ST., NEW MANILA, BARANGAY MARIANA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNERS, WITH POSTAL ADDRESS AT NO. 19 TIRAD PASS ST., AYALA HEIGHTS, BARANGAY OLD BALARA, QUEZON CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.
