ORDINANCE NO. SP- 907 - S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF PERRA CREST TOWNHOMES; RESIDENTIAL TOWNHOUSES WITH SEVENTEEN (17) UNITS, CONTAINING AN AGGREGATE AREA OF TWO THOUSAND SEVEN HUNDRED METERS, COVERED TRANSFER BYSOUARE FIFTY-FOUR (2.754)CERTIFICATE OF TITLE NUMBERED N-211883 AND N-210960 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF PERRA ESTATE CORPORATION AND ISIDRO F.
