AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH FIFTEEN (15) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SIX HUNDRED SQUARE METERS AND TWENTY SQUARE DECIMETERS (600.20 SQ. M.), COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 82491, 82492 & 82493, OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAMES OF MATILDE T. REYES, AURORA T. CHONG AND RODRIGO Q. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED :

SECTION 1.
