ORDINANCE NO. SP- 917 - S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH TWENTY-SIX (26) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND ONE HUNDRED FIFTY-SEVEN SQUARE METERS (1,157 SQ. M.), COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-194316 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SAMAHANG DEMOKRATIKO PAGKAKAISA NG MGA MARALITA HOMEOWNERS ASSOCIATION, INC., AND LOCATED AT LOT 101, FLS-2696-D, LYDIA ST., BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED :

SECTION 1. The subdivision plan of a RESIDENTIAL HOUSING PROJECT (BP BLG. 220) with twenty six (26) lots, Community Mortgage Program, containing an area of One Thousand One Hundred Fifty-Seven square meters (1,157 sq. m.), covered by Transfer Certificate of Title Numbered N-194316 of the Registry of Deeds of Quezon City, registered in the name of SAMAHANG DEMOKRATIKO PAGKAKAISA NG MGA MARALITA HOMEOWNERS ASSOCIATION, INC., and located at Lot 101, Fls-2696-D, Lydia St., Barangay Sta. Monica, Novaliches, Quezon City, Metro Manila, as applied for by the OWNER, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows :
