ORDINANCE NO. SP-922, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH TWELVE (12) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED TWENTY (520) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-179406 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF AGUARDIENTE IDEAL LAND ASSOCIATION, INC. (AGILA INC.), AND LOCATED AT LOT 78, FLS-2696-D, KILYAWAN STREET, SITIO AGUARDIENTE, BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a SOCIALIZED HOUSING PROJECT (BP Blg. 220) with twelve (12) lots, Community Mortgage Program, containing an area of Five Hundred Twenty (520) square meters, covered by Transfer Certificate of Title Numbered N-179406 of the Registry of Deeds of Quezon City, registered in the name of AGUARDIENTE IDEAL LAND ASSOCIATION, INC., and located at Lot 78, Fls-2696-D: Kilyawan Street, Sitio Aguardiente, Barangay Sta. Monica, Novaliches, Quezon City, Metro Manila, as applied for by the Owner, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:


