AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LOT 21, BLK. 17, A SOCIALIZED RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH NINETY-NINE (99) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE THOUSAND FOUR HUNDRED FIFTY-FOUR SQUARE METERS AND SEVENTY SQUARE DECIMETERS (5,454.70 SQ.M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 262148 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF QUEZON CITY GOVERNMENT (VENDOR), AND LOCATED AT LOT 21, BLOCK 17, MOORE STREET, BARANGAY BUNGAD, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE LOT 21, BLOCK 17 OLD TENANTS ASSOCIATION (VENDEE), SUBJECT TO THE CONDITIONS PRESCRIBED UNDER ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Lot 21, Block 17, a Socialized Residential Housing Project (BP Blg. 220) with ninety-nine (99) lots, Community Mortgage Program, containing an area of Five Thousand Four Hundred Fifty-Four square meters and Seventy square decimeters (5,454.70 sq.m.) covered by Transfer Certificate of Title Numbered 262148 of the Registry of Deeds of Quezon City, registered in the name of Quezon City government (Vendor), and located at Lot 21, Block 17, Moore Street, Barangay Bungad, Quezon City, Metro Manila, as applied for by the Lot 21, Block 17 Old Tenants Association (Vendee), is hereby approved, subject to the conditions prescribed under Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220 details of which are as follows:




