ORDINANCE APPROVING THE SUBDIVISION PLAN SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH ONE HUNDRED COMMUNITY MORTGAGE PROGRAM, (115)LOTS; FIFTEEN CONTAINING AN AREA OF NINE THOUSAND NINE HUNDRED SEVENTY-TWO (9,972) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 116098, 149553, 46558, 165365 AND 49909 OF THE REGISTRY OF DEEDS OF QUEZON CITY AND LOCATED AT VIRGINIA ST. AND DR. VILLAREAL ST., JOAN OF ARC, BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG MAGKAKAPITBAHAY NG JOAN OF ARC HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO.
