AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH TWENTY-ONE (21) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND TWO HUNDRED FIFTY-FIVE SQUARE METERS (1,255 SQ. M.), COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-190606 AND 12605 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SAMAHANG MAGKAKAPITBAHAY NG SITIO AGUARDIENTE HOMEOWNERS ASSOCIATION, INC., AND LOCATED AT LOT 29-B (LRC) PSD-194367 & LOT 30, FLS-2696-D, MAGDALENA ST., BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a SOCIALIZED HOUSING PROJECT (BP BLG. 220) with twenty-one (21) lots, Community Mortgage Program, containing an area of One Thousand Two Hundred Fifty-Five square meters (1,255 sq. m.), covered by Transfer Certificates of Title Numbered N-190606 and 12605 of the Registry of Deeds of Quezon City, registered in the name of SAMAHANG MAGKAKAPITBAHAY NG SITIO AGUARDIENTE HOMEOWNERS ASSOCIATION, INC., and located at Lot 29-B (LRC) Psd-194367 & Lot 30, Fls-2696-D, Magdalena St., Barangay Sta.
