ORDINANCE NO. SP- ~~558~~ S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH 50-LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TWO THOUSAND FOUR HUNDRED THIRTY-SIX (2,436) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-111215 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 735-U, FLS-2568-D, KADALAGAHAN STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG MAGKAKAPITBAHAY NG KADALAGAHAN HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a Socialized Housing Project (BP Blg. 220) with 50-lots, Community Mortgage Program, containing an area of Two Thousand Four Hundred Thirty-Six (2,436) square meters, covered by Transfer Certificate of Title Numbered RT-111215 of the Registry of Deeds of Quezon City, and located at Lot 735-U, FLS-2568-D, Kadalagahan Street, Barangay Gulod, Novaliches, Quezon City, Metro Manila, as applied for by the Samahang Magkakapitbahay ng Kadalagahan Homeowners Association, Inc., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows :


