ORDINANCE NO. SP- 962 , S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF AN ECONOMIC HOUSING PROJECT (BP BLG. 220) WITH 8-UNIT TOWNHOUSES, CONTAINING AN AREA OF FOUR HUNDRED (400) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-215968 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY SPOUSES NOEL ROBERTO & PIA MARGARITA U. ESCUETA, AND LOCATED AT LOT 6, BLOCK 24 (LRC) PCS-8124, HILLMAN STREET, FAIRVIEW PARK SUBDIVISION, BARANGAY FAIRVIEW, QUEZON CITY, METRO MANILA, AND AS APPLIED FOR BY THE OWNERS, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1. The subdivision plan of an Economic Housing Project (BP Blg. 220) with 8-unit townhouses, containing an area of Four Hundred (400) square meters covered by Transfer Certificate of Title Numbered N-215968 of the Registry of Deeds of Quezon City, owned by Spouses Noel Roberto & Pia Margarita U. Escueta, and located at Lot 6, Block 24 (LRC) Pcs-8124, Hillman Street, Fairview Park Subdivision, Barangay Fairview, Quezon City, Metro Manila, and as applied for by the owners, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220.
