AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A HOUSING PROJECT (BP BLG. 220) WITH ONE HUNDRED SEVENTY-FOUR (174) LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AGGREGATE AREA OF EIGHT THOUSAND THREE HUNDRED EIGHTY-SEVEN (8,387) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 99478, 99472, 99473, 99474, 99475, 99476, 99477, 99479, 99480, 99481, 99482, 99483, 99484, 99485, 99486, 99487, 99488, 99489, 99490 AND 99491 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT QUIRINO HIGHWAY, ROLLING HILLS SUBDIVISION, BARANGAY KALIGAYAHAN, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY KAPIT-BISIG NG JUNJI ROLLING HILLS HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
SESSION ASSEMBLED:


SECTION 1. The subdivision plan of a Socialized Housing Project (BP) Blg. 220 with One Hundred Seventy-Four (174) lots: Community Mortgage Program, containing an aggregate area of Eight Thousand Three Hundred Eighty-Seven (8,387) square meters covered by Transfer Certificates of Title Numbered 99478, 99472, 99473, 99474, 99475, 99476, 99477, 99479, 99480, 99481, 99482, 99483, 99484, 99485, 99486, 99487, 99488, 99489, 99490 and 99491 of the Registry of Deeds of Quezon City, located at Quirino Highway, Rolling Hills Subdivision, Barangay Kaligayahan, Novaliches, Quezon City, Metro Manila, as applied for by the Kapit-Bisig ng Junji Rolling Hills Homeowners Association, Inc., is hereby approved subject to the conditions prescribed under Quezon City Ordinance No. SP- 56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:


