ORDINANCE NO. SP- 966 ,-S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH THIRTY-ONE (31) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND TWO HUNDRED FOURTEEN (1,214) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-72137 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 7, BLOCK 20, PCS-2874, KAGAWAD ST. CORNER SESSION ROAD, AREA C, TALANAY, BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AND AS APPLIED FOR BY THE SAMAHAN NG NAGKAKAISANG MAGKAKAPITBAHAY SA SITIO TALANAY HOMOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a SOCIALIZED HOUSING PROJECT (BP Blg. 220) with thirty-one (31) lots, Community Mortgage Program, containing an area of One Thousand Two Hundred Fourteen (1,214) square meters covered by Transfer Certificate of Title Numbered RT-72137 of the Registry of Deeds of Quezon City, and located at Lot 7, Block 20, Pcs-2874, Kagawad St. corner Session Road, Area C, Talanay, Barangay Batasan Hills, Quezon City, Metro Manila, and as applied for by the SAMAHAN NG NAGKAKAISANG MAGKAKAPITBAHAY SA SITIO TALANAY HOMOWNERS ASSOCIATION, INC., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
