ORDINANCE NO. SP- 967, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF BLOOMFIELDS SUBDIVISION, TWO (2) STOREY, SINGLE DETACHED TOWNHOUSE WITH FOUR HUNDRED TWENTY THREE (423) LOTS CONTAINING AN AREA OF EIGHTY-SEVEN THOUSAND TWENTY TWO (87,022) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 124242 & 124243 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY ROBINSONS LAND CORPORATION AND LOCATED AT LOTS NO. 884-NEW & 887-NEW, SWO-8031, TALA ESTATE, BARANGAY PASONG PUTIK PROPER, NOVALICHES, QUEZON CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of BLOOMFIELDS SUBDIVISION, two (2) Storey, Single Detached Townhouse with Four Hundred Twenty Three (423) lots containing an area of Eighty Seven Thousand Twenty Two (87,022) square meters covered by Transfer Certificates of Title Numbered 124242 & 124243 of the Registry of Deeds of Quezon City owned by ROBINSONS LAND CORPORATION and located at Lots No. 884-New & 887-New, SWO-8031, Tala Estate, Barangay Pasong Putik Proper, Novaliches, Quezon City, Metro Manila, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and PD 957, details of which are as follows:
