ORDINANCE NO. SP- 968 - S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH TWENTY-ONE (21) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND ONE HUNDRED SEVENTY-ONE (1,171) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-53966 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 2, BLOCK 8, PCS-2874; PRESIDENTIAL STREET, BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SITIO 6 HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP. 56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a Socialized Housing Project (BP) Blg. 220 with Twenty-one (21) lots, Community Mortgage Program, containing an area of one thousand one hundred seventy-one (1,171) square meters covered by Transfer Certificate of Title Numbered RT-53966 of the Registry of Deeds of Quezon City, located at Lot 2, Block 8, PCS 2874; Presidential Street, Barangay Batasan Hills, Quezon City, Metro Manila, as applied for by the SITIO 6 HOMEOWNERS ASSOCIATION, INC., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP 56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
