ORDINANCE NO. SP- 970 - S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH FIFTEEN (15) LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED EIGHTY-FIVE (585) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-49441 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 26-B (LRC) PSD-647; NO. 80 SAMONTE ST., INTERIOR, BARANGAY HOLY SPIRIT, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE UNITED RESIDENTS OF DILIMAN NEIGHBORHOOD ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a SOCIALIZED HOUSING PROJECT (BP Blg. 220) with fifteen (15) lots, Community Mortgage Program, containing an area of Five Hundred Eighty-Five (585) square meters, covered by Transfer Certificate of Title Numbered RT-49441 of the Registry of Deeds of Quezon City, located at Lot 26-B (LRC) Psd-647; No. 80 Samonte St., Interior, Barangay Holy Spirit, Quezon City, Metro Manila, as applied for by the UNITED RESIDENTS OF DILIMAN NEIGHBORHOOD ASSOCIATION, INC., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
