ORDINANCE NO. SP- 973 S-2000

AN ORDINANCE CREATING FIVE (5) PLANTILLA POSITIONS OF DENTIST II (SALARY GRADE 16) IN THE CITY HEALTH DEPARTMENT AND APPROPRIATING THE AMOUNT OF ONE MILLION TWO HUNDRED EIGHTY-ONE THOUSAND ONE HUNDRED SEVENTY PESOS (P1,281,170.00) CHARGEABLE AGAINST THE REORGANIZATION FUND OF THE CITY'S ANNUAL BUDGET FOR CY 2001.

WHEREAS, the City Council under Sec. 458 (a) (I) (viii) of the Local Government Code is empowered to "determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

WHEREAS, the Honorable City Mayor has seen the need to create additional five (5) positions of Dentist II to serve the need of his constituents in the five (5) Health Districts of the City;

WHEREAS, the present manpower (dental) complement is shown to be inadequate to meet the needs of the city's growing population, particularly in the depressed areas;

WHEREAS, upon this representation, the City Council has deemed it necessary to create the above additional positions of Dentist II in the said department;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby created additional five (5) positions of Dentist II (Salary Grade 16) in the City Health Department.


SECTION 2. The amount of One Million Two Hundred Eighty-One Thousand One Hundred Seventy Pesos (P1,281,170.00) necessary to cover the salaries, insurance and other benefits of the said positions is hereby appropriated chargeable against the Reorganization Fund provided in the City's Annual Budget for CY 2001.

SECTION 3. This Ordinance shall take effect upon its approval.
