ORDINANCE NO.SP- 977 S-2000

AN ORDINANCE CREATING FOUR (4) PLANTILLA POSITIONS OF UTILITY WORKER II (SALARY GRADE 3) IN THE CITY ACCOUNTING DEPARTMENT AND APPROPRIATING THE NECESSARY AMOUNT OF FOUR HUNDRED FIFTY-THREE THOUSAND FOUR HUNDRED THIRTY-TWO PESOS (P453,432.00) CHARGEABLE AGAINST THE REORGANIZATION FUND OF THE CITY'S ANNUAL BUDGET FOR CY 2001

WHEREAS, the City Council under Sec. 458 (a) (1) (viii) of the Local Government Code is empowered to "determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the City government;"

WHEREAS, the City Accountant in the attached letter dated 04 December 2000, has determined and thus requested the creation of four (4) positions of Utility Worker II, Salary Grade 3 in the City Accounting Department in order to augment the existing three positions thereat and enable it to absorb the remaining employees formerly working as Utility Workers under the old plantilla;

WHEREAS, the City Council has deemed it necessary to create the above additional positions of Utility Worker II in the said department.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby created additional four (4) positions of Utility Worker II (Salary Grade 3) in the City Accounting Department.

SECTION 2. The amount of Four Hundred Fifty-Three Thousand Four Hundred Thirty-Two Pesos (P453,432.00) necessary to cover the salaries, insurance and other benefits of the said positions is hereby appropriated chargeable against the Reorganization Fund provided in the City's Annual Budget for CY 2001.
