ORDINANCE NO. SP 978 - 2000

AN ORDINANCE AUTHORIZING THE GRANT OF 5th STEP INCREASE TO THE POSITIONS OF DENTIST II TO DENTIST IV UNDER THE CITY HEALTH DEPARTMENT AND APPROPRIATING THE AMOUNT NECESSARY THEREFOR AMOUNTING TO ONE MILLION AND TWO HUNDRED THOUSAND PESOS (P1,200,000.00) CHARGEABLE AGAINST THE REORGANIZATION FUND OF THE CITY'S ANNUAL BUDGET FOR CY 2001.

WHEREAS, under Sec. 458 (a) (1) (viii) of the Local Government Code, the Sangguniang Panglungsod is empowered to "determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;"

WHEREAS, pursuant to the said authority, the City Council has authorized the upgrading of positions of the Public Health Nurse of the City Health Department from Salary Grade 14 to Salary Grade 16 equal to that of Dentist II which upgrading is now incorporated in the City's Annual Budget for CY 2001;

WHEREAS, because of the urgent request of those belonging to the Dental Group for a similar upgrading of their positions, the City Council has seen the need to grant the salary adjustment by way of step increases in order not to disrupt the salary grade allocation for their positions as provided in the Index of Occupational Services for positions in the local government units.

NOW, THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The positions belonging to the Dental Group under the City Health Department (from Dentist II to Dentist IV) are hereby granted step increase up to the 5th step of their present salary grade levels, as follows:

SECTION 2. The amount of One Million and Two Hundred Thousand Pesos (P1,200,000.00) necessary to implement the step increase authorized in the preceding section shall be taken from the Reorganization Fund provided in the City's Annual Budget for CY 2001.

SECTION 3. This Ordinance shall take effect upon its approval.
