ORDINANCE NO. SP- 987, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF AN ECONOMIC/SOCIALIZED RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH FOUR HUNDRED SIXTY-SEVEN (467) LOTS, CONTAINING AN AREA OF TWENTY-SEVEN THOUSAND NINE HUNDRED NINETY-ONE SQUARE METERS (27,991 SQ.M.), COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 54002 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF DOWAL REALTY AND MANAGEMENT SYSTEMS COMPANY (VENDOR), AND LOCATED AT LOT 57-E-2, PSD-13-014125, MAD-JAAS ROAD, PAYATAS B, BARANGAY PAYATAS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE GROUP 2 NEIGHBORHOOD ASSOCIATION (VENDEE), REPRESENTED BY MR. ALEX V. ADAN, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of an Economic/Socialized Residential Housing Project (BP Blg. 220) with Four Hundred Sixty-Seven (467) lots, containing an area of Twenty-Seven Thousand Nine Hundred Ninety-One square meters (27,991 sq.m.) covered by Transfer Certificate of Title No. 54002 of the Registry of Deeds of Quezon City, registered in the name of Dowal Realty and Management Systems Company (Vendor), and located at lot 57-E-2, Psd-13-014125, Mad-jaas Road, Payatas B, Barangay Payatas, Quezon City, Metro Manila, as applied for by the Group 2 Neighborhood Association (Vendee), represented by Mr. Alex V. Adan, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
