ORDINANCE NO. SP- 990 - S-2001

AN ORDINANCE AMENDING SECTIONS 1 AND 2 OF ORDINANCE NO. SP-896, S-2000 BY EXCLUDING FROM ITS COVERAGE RESTAURANTS AND GROCERY STORES IN THE PAYMENT OF INCREASED RATES FOR FILING FEES AND ISSUANCE OF PERMITS TO SELL OR PRODUCE LIQUOR PRESCRIBED THEREIN.

WHEREAS, Ordinance No. SP- 896, S-2000 amended Ordinance No. SP-91, S-93 by increasing the fees for the filing and issuance of permit to sell or produce liquor;

WHEREAS, considering the limited capital and clientele of restaurants and grocery stores, the City government has seen the need to exclude them from the payment of increased rate of taxes and fees prescribed in Ordinance No. SP-896, S-2000, supra;


NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Sections 1 and 2 of Ordinance No. SP-896, S-2000, which increased the rates for the payment of filing fees and issuance of permits to sell or produce liquor are hereby amended by excluding from the coverage restaurants and grocery stores. Accordingly, the payment of filing fees for the issuance of special permits to sell or produce the liquor as well as the tax rate for the sale thereof in restaurants and grocery stores shall be fixed at the old rate prescribed in Ordinance No. SP-91, S-93.


SECTION 2. This Ordinance shall take effect upon its approval.
