ORDINANCE NO. SP- 998

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH NINETEEN (19) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND SEVEN HUNDRED FIFTY (1,750) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-119163 & RT-115800 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT BANLAT, TANDANG SORA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SIXTO EXTENSION NEIGHBORHOOD ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a Socialized Housing Project (BP Blg. 220) with nineteen (19) lots, Community Mortgage Program, containing an area of One Thousand Seven Hundred Fifty (1,750) square meters covered by Transfer Certificates of Title Numbered RT-119163 & RT-115800 of the Registry of Deeds of Quezon City, located at Banlat, Tandang Sora, Quezon City, Metro Manila, as applied for by the Sixto Extension Neighborhood Association, Inc., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and PD 957.
