ORDINANCE NO. SP- ~~1001~~ S-2001

AN ORDINANCE AUTHORIZING THE OFFICIALS OF THE COMMISSION ON ELECTIONS ASSIGNED IN QUEZON CITY TO RECEIVE MONTHLY ALLOWANCES/HONORARIA AND APPROPRIATING FUNDS THEREFOR.

Introduced by Councilors ERIC Z. MEDINA, VINCENT P. CRISOLOGO, WINSTON "Winnie" T. CASTELO, GODOFREDO T. LIBAN II, MARCIANO P. MEDALLA, ENRICO S. SERRANO and JORGE L. BANAL.

WHEREAS, Sec. 458 (a) (1) (xi) of the Local Government Code provides:

"Section 458 (a) (1) (xi). When the finances of the City government allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the city;

WHEREAS, Commission on Elections officials and employees are considered as other national government officials stationed in Quezon City who may be entitled to receive allowances/honoraria;

WHEREAS, in the Minute Resolution No. 00-0214 promulgated on February 10, 2000 by the Commission on Elections en banc where it resolved;

"Wherefore, The Commission Resolved as it hereby resolves to allow COMELEC field officials to receive any allowance in the form of honoraria from local government units concerned where they are assigned/stationed."

WHEREAS, in recognition of the efficient performance of their avowed function to protect the sanctity of the ballots during election, it is justified to grant local election officials and employees honoraria, thus the imperativeness of this ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Each of the Election Registrars assigned in the four congressional districts of Quezon City shall receive a monthly allowance of Two Thousand Pesos (P2,000) per month;


SECTION 2. The rank and file assigned under each of the four districts shall receive an allowance ranging from Five Hundred Pesos (P500.00) to One Thousand Five Hundred Pesos (P1,500.00) monthly in accordance with their respective positions.

SECTION 3. The Office of the City Mayor shall take charge in the implementation of this ordinance;


SECTION 4. This Ordinance shall take effect upon its approval.

SECTION 5. There shall be appropriated so much amount to be taken from the discretionary fund of the City Mayor for the implementation of this ordinance.
