AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF MADRINAN TOWNHOUSE PROJECT WITH HEIGHTS (A 3-STOREY CONTAINING AN AREA OF ONE THOUSAND THREE HUNDRED THIRTY-SQUARE DECIMETERS AND THIRTY METERS SOUARE (1,336.30 SQ. M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-218424 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF HOBART REALTY AND DEVELOPMENT CORP., AND LOCATED AT LOT 4, BLOCK S-19 NO. 44 SCOUT MADRINAN STREET, BARANGAY SOUTH TRIANGLE, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED.
