AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LUPANG PINAGKAISAHAN NG FAIRVIEW **QUEZON** CITY **NEIGHBORHOOD** ASSOCIATION, INC., A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH ONE THOUSAND ONE HUNDRED TWENTY-FIVE (1,125) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SIXTY THOUSAND FOUR HUNDRED SEVENTY-SEVEN (60,477) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 186700 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY THE QUEZON CITY GOVERNMENT (VENDOR), AND LOCATED AT LOT 1 BLOCK 10, PSD-168289 RUBY STREET, EAST FAIRVIEW, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE LUPANG PINAGKAISAHAN NG FAIRVIEW QUEZON CITY NEIGHBORHOOD ASSOCIATION, INC., (VENDEE), SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Lupang Pinagkaisahan ng Fairview Quezon City Neighborhood Association, Inc., a Socialized Housing Project (BP Blg. 220) with one thousand one hundred twenty-five (1,125) lots, Community Mortgage Program, containing an area of sixty thousand four hundred seventy-seven (60,477) square meters covered by Transfer Certificate of Title Numbered 186700 of the Registry of Deeds of Quezon City, owned by the Quezon City government (vendor), and located at Lot 1 Block 10, Psd-168289 Ruby Street, East Fairview, Quezon City, Metro Manila, as applied for by the Lupang Pinagkaisahan ng Fairview Quezon City Neighborhood Association, Inc., (vendee), is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg, 220, details of which are as follows:
