ORDINANCE NO. SP- ~~1016~~ S-2001

AN ORDINANCE CREATING THIRTY-EIGHT (38) PERMANENT PLANTILLA POSITIONS IN THE LIQUOR LICENSING REGULATORY BOARD OF QUEZON CITY AND APPROPRIATING NECESSARY FUNDS THEREFOR.

Introduced by Councilors GODOFREDO T. LIBAN II, ELIZABETH A. DELARMENTE, WINSTON "WINNIE" T. CASTELO, MA. FRESCA M. BIGLANG-AWA, MARCIANO P. MEDALLA, ERIC Z. MEDINA, JORGE L. BANAL, JULIAN M.L. COSETENG, JESUS C. SUNTAY and NANETTE CASTELO DAZA.

WHEREAS, the Sangguniang Panlungsod, under City Ordinance No. NC-86, S-89, had created the Liquor and Licensing Regulatory Board under the Office of the City Mayor, tasked to undertake efficient implementation of liquor provisions under Ordinance No. NC-85, S-89, and to regulate the establishment and operation of the liquor business in Quezon City;

WHEREAS, Ordinance No. NC-86, S-89, only provides casual employees/staff excluding the members of the board to carry out and execute the duties and functions assigned which the Sangguniang Panlungsod had noted to be insufficient or the Board is undermanned due to the unprecedented increase of business establishments in the City engaged in the selling of liquor;

WHEREAS, the Liquor and Licensing Regulatory Board is one of the income generating offices of Quezon City wherein these past few months from September to December 2000, their records reflect a sizeable amount of collected revenues due to the efficient and effective implementation of liquor ordinance;

WHEREAS, there is a need to create permanent plantilla positions and increase/augment its present personnel composition so as to ensure and improve its collection and effectively conduct massive monitoring on establishments which are operating during nighttime.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Creation - The following permanent plantilla positions are hereby created under the Liquor and Licensing and Regulatory Board of Quezon City:

SECTION 2. Appropriation - An amount of Seven Million Five Hundred Thousand Pesos (P7,500,000.00) is hereby appropriated for the payment of salaries and wages, benefits, incentives, insurance premiums, 13th month pay, productivity bonus, PAG-IBIG contributions, clothing allowances, SIF, RATA, PERA, ACA, mid-year and such other emoluments applicable under existing laws and city ordinances.

SECTION 3. Function - The Liquor and Licensing Regulatory Board created under City Ordinance No. NC-86, S-89 shall remain to be the policy making body and shall continue to perform the powers and functions provided therein.

SECTION 4. Repealing Clause - All city ordinances, resolutions, rules and regulations and executive order and memoranda which are inconsistent with any of the provisions of this Code are hereby repealed or modified accordingly.

SECTION 5. Effectivity Clause - This Ordinance shall take effect immediately upon its approval.
