ORDINANCE NO. SP- ~~1017~~ - 2001

AN ORDINANCE UPGRADING THE SALARY GRADE OF DRIVER II PLANTILLA POSITIONS IN QUEZON CITY FROM SALARY GRADE 4 TO SALARY GRADE 6 AND APPROPRIATING NECESSARY FUNDS THEREFOR WHICH SHALL BE TAKEN FROM THE SAVINGS OF THEIR RESPECTIVE DEPARTMENTS.

Introduced by Councilors GODOFREDO T. LIBAN II, ERIC Z. MEDINA, VINCENT P. CRISOLOGO, MARCIANO P. MEDALLA, JORGE L. BANAL and JULIAN M.L. COSETENG.

WHEREAS, a letter of appeal was forwarded to the Office of the City Mayor by a group of employees of the Quezon City government who are holding permanent plantilla positions of Driver II with salary grade 4 or with a monthly income of Five Thousand Six Hundred Forty-Six Pesos (P 5,646.00);

WHEREAS, these employees in their letter alleged that as drivers they render service beyond the prescribed number of working hours or their time is not fixed as it depends on the needs of the department; that their working area is outside or on the road wherein they have to exercise extraordinary diligence to prevent road accident and ensure the safety of their office heads and co-employees;

WHEREAS, in the discharge of their duties, they have to be equipped with necessary licenses that had to be renewed from time to time, thus, entailing added expenses on their part unlike other employees who are just performing routine work but are receiving more;

WHEREAS, with the amount of Five Thousand Six Hundred Forty-Six Pesos (P 5,646.00) as their basic monthly salary, with the ongoing soaring of prices in basic commodities and the recent increase of driver's license fees, the same is not enough for them to meet their daily needs, thus there is a need to upgrade their salaries as this is the most reasonable and equitable under the present circumstances.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. The salary grade of Driver II plantilla positions in Quezon City is hereby upgraded from Salary Grade 4 to Salary Grade 6 and appropriating necessary funds therefor which shall be taken from the savings of their respective departments.

SECTION 2. This Ordinance shall take effect immediately upon its approval.


