ORDINANCE NO. SP 1020 8-2001

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF TAWID SAPA II PHASE E A SOCIALIZED HOUSING PROJECT (BP Big 220) WITH THREE MORTGAGE THIRTY-FIVE (335)LOTS, COMMUNITY HUNDRED PROGRAM, CONTAINING AN AREA OF TWENTY THOUSAND HUNDRED FORTY-TWO (20,642) SQUARE METERS COVERED TRANSFER CERTIFICATE OF TITLE NUMBERED 35564 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY THE QUEZON CITY 896, BARANGAY GOVERNMENT (VENDOR), LOCATED AT LOT KALIGAYAHAN, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG TAWID SAPA II PHASE I HOMEOWNERS ASSOCIATION, INC., VENDEE, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Tawid Sapa II Phase 1; a Socialized Housing Project (BP blg 220) with Three Hundred Thirty-Five (335) lots, Community Mortgage Program, containing an area of Twenty Thousand Six Hundred Forty-Two (20,642) square meters covered by Transfer Certificate of Title Numbered 15564 of the Registry of Deeds of Quezon City, owned by the Quezon City government (vendor), located at Lot 896, Barangay Kaligayahan, Quezon City, Metro. Manila, as applied for by the Samahang Tawid Sapa II Phase I Homeowners Association, Inc., vendee is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
