AN ORDINANCE RECTIFYING CERTAIN NOMENCLATURE AND SALARY GRADES OF VARIOUS POSITIONS UNDER THE QUEZON GOVERNMENT

Introduced by Councilor **GODOREDO T. LIBAN II.**

Co-Introduced by Councilors **Elizabeth A. Delarmente, Winston "Winnie" T. Castelo, Ma. Fresca M. Biglang-awa, Marciano P. Medalla, Eric Z. Medina, Jorge L. Banal, Julian M.L. Coseteng, Nanette Castelo Daza and Jesus C. Suntay.**

WHEREAS, certain nomenclature and salary grades of various positions under the Quezon City Government are no longer in accordance with the DBM Index of Occupational Services, Position Titles and Salary Grades (IOS) and the Qualification Standards (QS) Manual of the Civil Service Commission;

WHEREAS, some of these positions were reclassified by the Salary Standardization Committee created during the past dispensation which positions must be returned to their former position titles for practicable reasons and to cut the merging needs of the times;

WHEREAS, appointments issued bearing the said nomenclature and salary grades may have some technical and legal defects and unless amended, may meet CSC disapproval;

WHEREAS, said nomenclature and salary grades of certain positions have to be rectified to cure the defects;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The following nomenclature and salary grades shall be amended as indicated hereunder:


