AN ORDINANCE SEPARATING LAGRO HIGH SCHOOL MALIGAYA ANNEX FROM ITS MOTHER SCHOOL LOCATED AT BARANGAY PASONG PUTIK.

Introduced by Councilors GODOFREDO T. LIBAN II, ERIC Z. MEDINA, JESUS C. SUNTAY, VINCENT P. CRISOLOGO and MA.FRESCA M. BIGLANG-AWA.

WHEREAS, the Sangguniang Barangay of Barangay Pasong Putik has adopted a resolution entitled: "Requesting the City Council to approve and facilitate the distinct separation and independent operation and administration of Maligaya High School Annex from Lagro High School and subsequently renaming the former as Maligaya High School and formally placing it under the territorial jurisdiction of Barangay Pasong Putik Proper,"

WHEREAS, the Central Parents Teachers Community Association, Lagro High School, Maligaya Park Annex had also adopted a resolution petitioning the Honorable Secretary of Education, Culture and Sports with the help of the Schools' Division Superintendent to take positive action or the taking of Lagro High School-Maligaya Park Annex with all the legal implications such as its independence from its mother institution;



WHEREAS, all pertinent requirements as prescribed by the Department of Education, Culture and Sports had been complied with and what is left to be done is the City Council resolution or ordinance separating the said Annex school and establishing an independent school to be known as Maligaya High School;

WHEREAS, there is a need to pass and approve an ordinance to facilitate the immediate separation and independency of Maligaya High School with all its powers and attributes as independent secondary school.

NOW, THEREFORE:


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Lagro High School - Maligaya Annex located at Barangay Pasong Putik Proper is hereby separated from its mother school and an independent high school to be known as Maligaya High School, Barangay Pasong Putik Proper is hereby established.






SECTION 2 This Ordinance shall take effect immediately upon approval
