ORDINANCE NO. SP- ~~1037~~, S-2001

AN ORDINANCE UPGRADING THE POSITION CLASSIFICATION OF THE DEPUTY TREASURERS OF THE OFFICE OF THE CITY TREASURER FROM THE POSITION OF LOCAL REVENUE COLLECTION OFFICER III TO LOCAL REVENUE COLLECTION OFFICER IV AND THE CORRESPONDING SALARY THEREFOR TO GRADE 22.

WHEREAS, the City Council pursuant to Section 458 (a) (1) (viii) of the Local Government Code is empowered to;

“ Determine the positions and the salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, project, services, and activities of the city government.”

WHEREAS, there exist four (4) plantilla positions for Deputy Treasurers classified as Local Revenue Collection Officer III;

WHEREAS, pursuant to Ordinance No. SP-345, S-95, employees holding the position of cashier were reclassified to Salary Grade 18 from Grade 14 which is equivalent to the rank of Local Revenue Collection Officer III;

WHEREAS, the responsibility of Deputy Treasurers is more tasking and wider in scope as they represent the personality of the City Treasurer in their respective districts in increasing revenue for the city government;

WHEREAS, Deputy Treasurers are accountable to the public funds collected by them in their respective districts, such as business taxes and licenses, real estate taxes, fees and charges, etc.;

WHEREAS, in order to give recognition to the function of the District Treasurers and, likewise, as an incentive to them for their efforts for increasing revenue collections of the government, it is imperative that their position be upgraded from Local Revenue Collection Officer III to Local Revenue Collection Officer IV.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1. The position classified as Local Revenue Collection Officer III in the Office of the City Treasurer is hereby reclassified and upgraded to Revenue Collection Officer IV.

SECTION 2. That the salary grade attached to the position shall also be given corresponding adjustment and received by the employee discharging the function.


SECTION 3. That the incumbent employees holding the position shall receive salary grade 22 subject to the Civil Service rules and regulations.

SECTION 4. That the funds needed therefor shall be taken from any appropriation needed for the purpose.

SECTION 5. The Office of the Mayor through the Personnel Department and Budget Department shall take charge in the implementation of this ordinance.

SECTION 6. This ordinance shall take effect upon approval hereof.
