ORDINANCE NO. SP- 1040, §-2001

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE PATROLMAN TOMAS A. MARCELO, A FORMER MEMBER OF THE CENTRAL POLICE DISTRICT OFFICE (CPDO), WHO DIED ON APRIL 21, 2000, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE OFFICE OF THE CITY MAYOR IN THE ANNUAL BUDGET FOR FISCAL YEAR 2001.

Introduced by Councilors ERIC Z. MEDINA, VINCENT P. CRISOLOGO, GODOFREDO T. LIBAN II, MA. FRESCA M. BIGLANG-AWA, MARCIANO P. MEDALLA, ROMMEL R. ABESAMIS, JORGE L. BANAL, JESUS C. SUNTAY and RAMON G. MATHAY.

WHEREAS, Patrolman Tomas A. Marcelo had faithfully served Quezon City and was not involved in any anomaly during his incumbency;

WHEREAS, Patrolman Marcelo had rendered Thirty-five (35) years of dedicated and loyal service to the people of Quezon City, starting as a lowly policeman in 1948 until his retirement in 1982;

WHEREAS, on April 21, 2000, Patrolman Marcelo died of natural cause, having been sick with CVA Trombosis;

WHEREAS, in recognition of his valuable, faithful and outstanding service to the Quezon City Government, it is only fair and just to extend financial assistance to his bereaved family;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. A financial assistance in the amount of Thirty Thousand Pesos (P30,000.00) is hereby granted to the bereaved family of the late Patrolman Tomas A. Marcelo who died on April 21, 2000.


SECTION 2. The amount mentioned in Section 1 hereof shall be charged against the appropriations of the Office of the City Mayor under grants, subsidies and contributions in the Annual Budget for Fiscal Year 2001.

SECTION 3. This ordinance shall take effect immediately upon its approval.
