ORDINANCE NO. SP- 1046 , S-2001

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG 220) WITH TWENTY NINE (29) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND THREE HUNDRED FIFTY (1,350) SQUARE METER, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-72099, RT-72096, RT-72100 AND RT-54568 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT KAGAWAD STREET, DOLOR SUBDIVISION, BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE RESOLUTION EXTENSION HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a Socialized Housing Project (BP Blg 220 with twenty nine (29) lots, Community Mortgage Program, containing an area of One Thousand Three Hundred Fifty (1,350) square meters, covered by Transfer Certificates of Title Numbered RT-72099, RT-72096, RT-72100 and RT-54568 of the Registry of Deeds of Quezon City, located at Kagawad Street, Dolor Subdivision, Barangay Batasan Hills, Quezon City, Metro Manila, as applied for by the RESOLUTION EXTENSION HOMEOWNERS ASSOCIATION, INC., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
