ORDINANCE NO. SP- 4082, S-2001

AN ORDINANCE CREATING SIX (6) PLANTILLA POSITIONS OF LEGISLATIVE AIDE (SG-3) UNDER THE LEGISLATIVE SERVICES DIVISION OF THE CITY SECRETARY'S OFFICE (OFFICE OF THE SECRETARY TO THE SANGGUNIAN), QUEZON CITY.

Introduced by Councilors ERIC Z. MEDINA, ROMMEL R. ABESAMIS, JORGE L. BANAL and MARCEL C. RILLO.

WHEREAS, one of the functions of the Office of the Secretary to the Sanggunian is to provide and extend legislative support to the members of the Sanggunian during its session;

WHEREAS, to effectively extend such support, there is an imperative need to have regular legislative aides who will act as pages/usherettes during Sanggunian sessions;

WHEREAS, pages are big help to the Sanggunian members, especially in the performance of their other official duties while in actual sessions.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. There is hereby created six (6) plantilla positions of Legislative Aide (SG-3) under the Legislative Services Division of the City Secretary's Office (Office of the Secretary to the Sanggunian), Quezon City.

SECTION 2. It shall be one of the duties and responsibilities of the appointees to the said positions of Legislative Aide to be present during the City Council's session and assist the Secretary to the Sanggunian and the Council Members in the performance of their official functions during said sessions.


SECTION 3. The amount of Six Hundred Eighteen Thousand Eight Hundred Ninety-One Pesos and Thirty Six Centavos (P618,891.36) is hereby appropriated from any available funds or savings of the Office of the Secretary to the Sanggunian under its appropriation for Personnel Services in the Annual Budget for Fiscal year 2001, to cover the payment for salaries and other benefits due to the said positions created under Section 1 hereof. Subsequent appropriations thereof shall be included in the Annual Budget of the City Government.

SECTION 4. This ordinance shall take effect immediately upon approval.
