ORDINANCE NO. SP-1000 S-2001

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A TWO STOREY TOWNHOUSE WITH LOWER GROUND FLOOR AND ATTIC PROJECT WITH 18 UNITS, CONTAINING AN AREA OF ONE THOUSAND SIX HUNDRED AND SEVENTY TWO SQUARE METER AND FORTY SQUARE DECIMETERS (1,672.40 SQ.M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-1218824 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF ALTAVILLE DEVELOPMENT CORPORATION AND LOCATED AT LOT 8, BLOCK 460 PSD-43461, NO. 108 DAPITAN STREET, BARANGAY STO. DOMINGO, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

Domingo, Quezon City, Metro Manila, as applied for by the owner, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Pd 957.


