ORDINANCE NO. SP- 10 63, S-2001

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE FORMER BARANGAY CHAIRMAN VIRGILIO G. YAP OF BARANGAY ESCOPA I WHO PASSED AWAY ON JUNE 2, 2001.

WHEREAS, Mr. VIRGILIO YAP, former Barangay Chairman of Barangay Escopa I, succumb to heart failure on June 2, 2001;

WHEREAS, Mr. Yap had served his Barangay with credibility and with honor for 16 years, 8 years as barangay kagawad and for 8 years as Barangay Chairman;

WHEREAS, in deference and in recognition of his dedicated services, it is but proper that the City government extend to his family a financial assistance as a traditional expression of sympathy and in order to lessen, in some way, the blow of the tragedy to his loved ones;

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED.

SECTION 1. The amount of Thirty Thousand Pesos (P30,000.00) is hereby allocated from any available fund in the City Treasury as financial assistance to the family of the late Virgilio G. Yap, former Barangay Chairman of Barangay Escopa I, who died of heart ailment on June 2, 2001.
