AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A HOUSING PROJECT, JUNJI ROLLING HILLS (PHASE II) (BP. BLG. 220) WITH TWO HUNDRED FORTY SEVEN (247) LOTS, COMMUNITY MORTGAGE PROGRAM CONTAINING AN AGGREGATE AREA OF TWELVE THOUSAND FOUR HUNDRED SEVEN SQUARE METERS (12,407 S.M.) COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 87338, 87339, 87340,87341, 87342, 87343, 87349, 87351, 87352, 87353, 8**7357, 8735**\$, 87359, 87360, 87361, 87362, 87363, 87364, 87365, 87366, **87367, 87369,** 87371,87372, 87373, 87375, 87377, 87378, & N-205556.
