ORDINANCE NO. SP-1072 "" S-2001

AN ORDINANCE MANDATING ALL DRIVERS OF PUBLIC UTILITY VEHICLES PLYING THE STREETS OF QUEZON CITY TO PROVIDE A RECEPTACLE CONSPICUOUSLY INSIDE THEIR RESPECTIVE VEHICLES FOR THE PROPER DISPOSAL OF TRASH/RUBBISH OF THEIR PASSENGERS AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458 (5) (xiii) of the Local Government Code of 1991 gives the Sangguniang Panlungsod the authority to approve ordinances for an efficient and effective system of solid waste and garbage disposal and prohibit littering and the placing or throwing of garbage, refuse and other filth and waste;

WHEREAS, there has been a marked increase in the number of jeepneys, buses and taxicabs traversing Quezon City daily carrying thousands of commuters, some of whom indiscriminately discard their trash/rubbish on our city streets contributing to the gradual clogging of canals which may eventually cause flash floods.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Drivers and operators of public utility vehicles plying the streets of Quezon City are mandated to provide a receptacle conspicuously inside their respective vehicles for their passengers to properly dispose of their trash/rubbish.

SECTION 2. Violation of this Ordinance shall be punishable as follows:

First Apprehension Second Apprehension Third Apprehension

- Three Hundred Pesos (P300.00)
- Six Hundred Pesos (P600.00)
- One Thousand Pesos (i*1.000.00) or imprisonment of not more than fifteen (15) days or both, at the discretion of the Court without prejudice to the fine imposed by P.D. 825.
