## ORDINANCE NO. SP-17 074, \$\frac{1}{2001}

AN ORDINANCE PROHIBITING SIDEWALK VENDORS OR ANY PERSON FROM SELLING OR VENDING THEIR WARES OR MERCHANDISE WITHIN THE PREMISES OF PEDESTRIAN OVERPASSES, PROVIDING PENALTISFOR VIOLATION THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, it is observed that sidewalk vendors are selling their wares within the premises of pedestrian overpassess, at the stairs thereof and its vicinity, thereby obstructing the free passage of pedestrians for whose use said overpasses was constructed;

WHEREAS, in the course of said vending activities, papers, wrappers, plastic bags, and other kinds of trash are scattered all over the place;

WHEREAS, the presence of such sidewalk vendors within the premises pedestrian overpasses stands in the way of our cleanliness and beautification programmed does violence to efforts to promote discipline and a sense of orderliness in City.

## NOW. THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. It is hereby prohibited for a sidewalk vendor or any other person to vend or sell their wares or merchanise within the premises of pedestrian overpassess, at the stairs thereof and its vicinity.

SECTION 2. Any violation of the provisions of Section 1 hereof shall punishable by an imprisonment of not less than five (5) days nor more than ten (1 days or a fine of not less than Fifty Pesos (P50.00) nor more than One Hundred Per (P100.00) at the discretion of the Court.
