ORDINANCE NO. SP-7 0 7 8, S-2001

AN ORDINANCE RENAMING NOVALICHES ELEMENTARY SCHOOL TO ROSA L. SUSANO-NOVALICHES ELEMENTARY SCHOOL.

Introduced by Councilors VOLTAIRE GODOFREDO L. LIBAN III, AIKO MELENDEZ-YLLANA, RAMON P. MEDALLA, ALLAN FRANCISCO, ERIC Z. MEDINA, JESUS C. SUNTAY, ALMARIO E. FRANCISCO, JANET M. MALAYA, WILMA AMORANTO-SARINO, ELIZABETH A. DELARMENTE, JORGE L. BANAL, VINCENT P. CRISOLOGO, WENCEROM BENEDICT C. LAGUMBAY, ANTONIO E. INTON, JR., and RESTITUTO B.MALANGEN.

WHEREAS, Section 13, par. (3) of the Local Government Code of 1991, authorizes the Sangguniang Panlungsod of highly urbanized cities to change the name of public elementary schools within its territorial jurisdiction;

WHEREAS, the present site of the Novaliches Elementary School was donated by the late Rosa L. Susano in the year 1916, out of liberality of her heart and prompted by her deep concern for the education of the people of Novaliches;

WHEREAS, during her lifetime, Mrs. Susano was a recognized civic leader who was widely known for her benevolence and deep concern for the welfare of the people;

WHEREAS, portion of the said land was previously rented out to the Philippine Constabulary, after which, upon its return to the owner, Rosa L. Susano began a nursery school, subsidizing the teachers and facilitate for the training of the pre-school children;

WHEREAS, in recognition of her unselfish services to the people, she was privileged at one time to serve as a member of the Quezon City Sangguniang Panlungsod;

WHEREAS, in gratitude for the land donation and in appreciation for her continued support to the Novaliches Elementary School and in memory for her outstanding, yet unpublished contribution in the field of education and the moral training of youth, it is most befitting that the school be renamed to Rosa L. Susano-Novaliches Elementary School;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. Novaliches Elementary School is hereby renamed Rosa L. Susano Novaliches Elementary School.
