ORDINANCE NO. SP-4085, 2001

AN ORDINANCE AMENDING ORDINANCE NO. SP-976, S-2000, OTHERWISE KNOWN AS "AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR ISMAEL A. MATHAY. JR., TO EXPROPRIATE THE PARCELS OF LAND SITUATED IN BANLAT, QUEZON CITY, IDENTIFIED AS LOT 1046-B-1 WITH AN AREA OF FIVE HUNDRED FIFTY (550) SQUARE METERS FOR THE PURPOSE OF ERECTING THE TANDANG SORA SHRINE AND THE RELEASE OF FUNDS NEEDED THEREFOR TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, Ordinance No. SP-976, S-2000, was enacted and approved on December 14, 2000;

WHEREAS, upon perusal of the comparative analysis submitted by the City Assessor's Office, as well as the memorandum report by the Parks Development and Administration Department (copies of which are hereto attached) it will be advantageous to and less burdensome for the City government to expropriate Lot 1115-B-1 with an area of one thousand nine hundred six (1,906) square meters, which on record is owned by Mr. Antonio Cabreros.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The City Mayor is hereby authorized to expropriate the parcel of land known as Lot 1115-B-1 containing an area of One Thousand Nine Hundred Six (1,906) square meters which on record is owned by Mr. Antonio Cabreros.

SECTION 2. The funds necessary in the expropriation proceedings will be taken from the Office of the City Mayor.

SECTION 3. The Office of the City Mayor, through the City Legal Officer and the City Assessor's Office shall take charge in the implementation of this Ordinance.
