ORDINANCE NO. SP-1091 S-2001

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. SP-1062, S-2001, FURTHER AMENDING ORDINANCE NO. SP-15, S-92, AS AMENDED BY ORDINANCE NO. SP-351, S-95, ORDINANCE NO. SP-479, S-96 AND ORDINANCE NO. SP-787, S-99, SO AS TO GRANT PER DIEM TO OTHER BOARD MEMBERS AND THE BOARD SECRETARY.

WHEREAS, Section 1 of Ordinance No. SP-1062, S-2001, the last paragraph of which states.

"The representatives from the Non-Governmental and Tricycle organization shall be elected at large by the president of their respective associations and shall hold office for one (1) year reckoned from the time of their election which shall be set by the Board within a reasonable time after the effectivity of this ordinance. They shall be entitled to a per diem of Seven Hundred Fifty Pesos (P750.00) each per meeting attended."

WHEREAS, the foregoing provision is inequitable and denial of the equal protection mantle of the ordinance to the other members of the Board, considering that the Chairman and the other members are performing the same function and consuming time during Board Hearings;

WHEREAS, the Board Secretary likewise performs the same burden of work and responsibility and consuming time to be rendered in the performance of his functions, is also entitled to a similar amount, thus, this amendment.

SESSION ASSEMBLED:


SECTION 1. The second paragraph of Section 1 of Ordinance No. SP-1062, S-2001, is hereby amended, to read as follows:

"The representative from the non-governmental and Tricycle Association shall be elected at large by the presidents of their respective associations and shall hold office for one (1) year reckoned from the time of their election which shall be set by the Board within a reasonable time after the effectivity of this ordinance. The chairman and all members including the Board Secretary shall be entitled to a per diem of Seven Hundred Fifty Pesos (P750.00) each per attended Board meeting."


SECTION 2. The grant of per-diem shall be reckoned/retroactive from the time the Franchising Board assumed its function after the effectivity of Ordinance No. SP-1062, S-2001.
